

SWIFTSTACK WEBSITE TERMS OF USE

These SwiftStack Website Terms of Use were last modified on 8th March 2016 and are effective on Your use of the SwiftStack website at www.swiftstack.com, (the "Site").

"We", "Us", or "Our" means the SwiftStack Inc., company with its principal place of business at 333 Bush St., Suite 1650, San Francisco, CA 94104.
